# Methods of Tracking Outreach Data

## 1. Encampment Module

- Available to view by all HMIS users
- Dashboard for external audiences in development

## 2. Outreach Program Data (Current Living Situations)

- Data is reported via Program Overview Street Outreach dashboard
- More details available via Looker to LAHSA & Provider Staff

## 3. Annual Point-in-Time Homeless Count

- Collected via volunteer visual count during the nights of the Homeless Count
- Data shared via Homeless Count dashboards and deliverables

# HMIS Encampment Module

## About the Module

- Full documentation [here](#).
- Comprised of shapes of various identified encampments and allows reporting based on clients who have a CLS within the encampment
  - For Inside Safe, Pathway Home, and ERFs there are also “encampment enrollments”
- Color Coded based on Encampment’s Status (planned operation, active operation, etc)

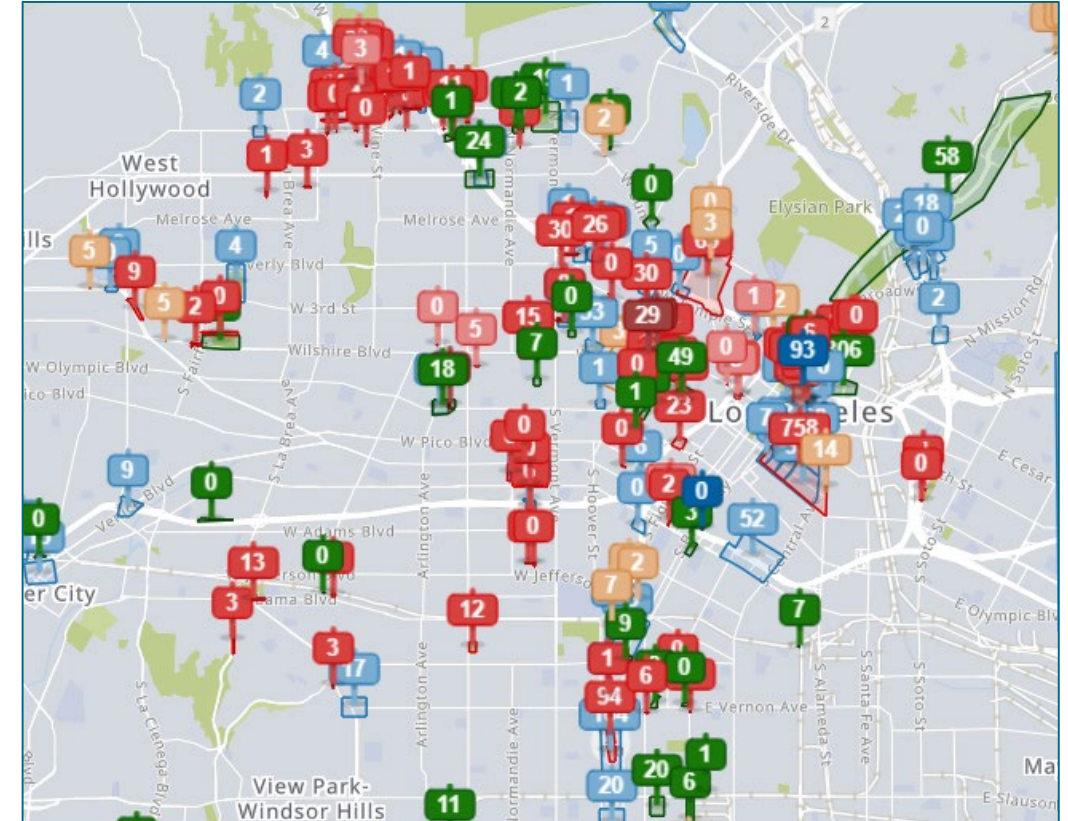
## Quick Facts About our Encampment Data

### Encampment Resolution Categories:

- 129 Inside Safe
- 34 Pathway Home
- 8 ERFs

### Statuses (as of 8/4/2025)

- 188 Known, No Currently Planned Operation
- 31 Planned Operations
- 8 Active Closures
- 138 Closed and Actively Maintained





# Outreach Program Data (Current Living

## Situations)

### About Outreach Geolocation Data

- Current Living Situations are meant to be created every time an outreach case worker interacts with a client, noting the location they were served
- Allow for counts of frequency of engagement with clients and the locations they reside in

### Current Unsheltered Data in City of LA

- 13,057 clients served in City of LA in FY25 Q4\*
  - *\*Based on having a single CLS in the period within City limits*
  - 37% were in active encampments
- 69,247 distinct interactions in Q4
- Average 5 interactions per client in FY25 Q4

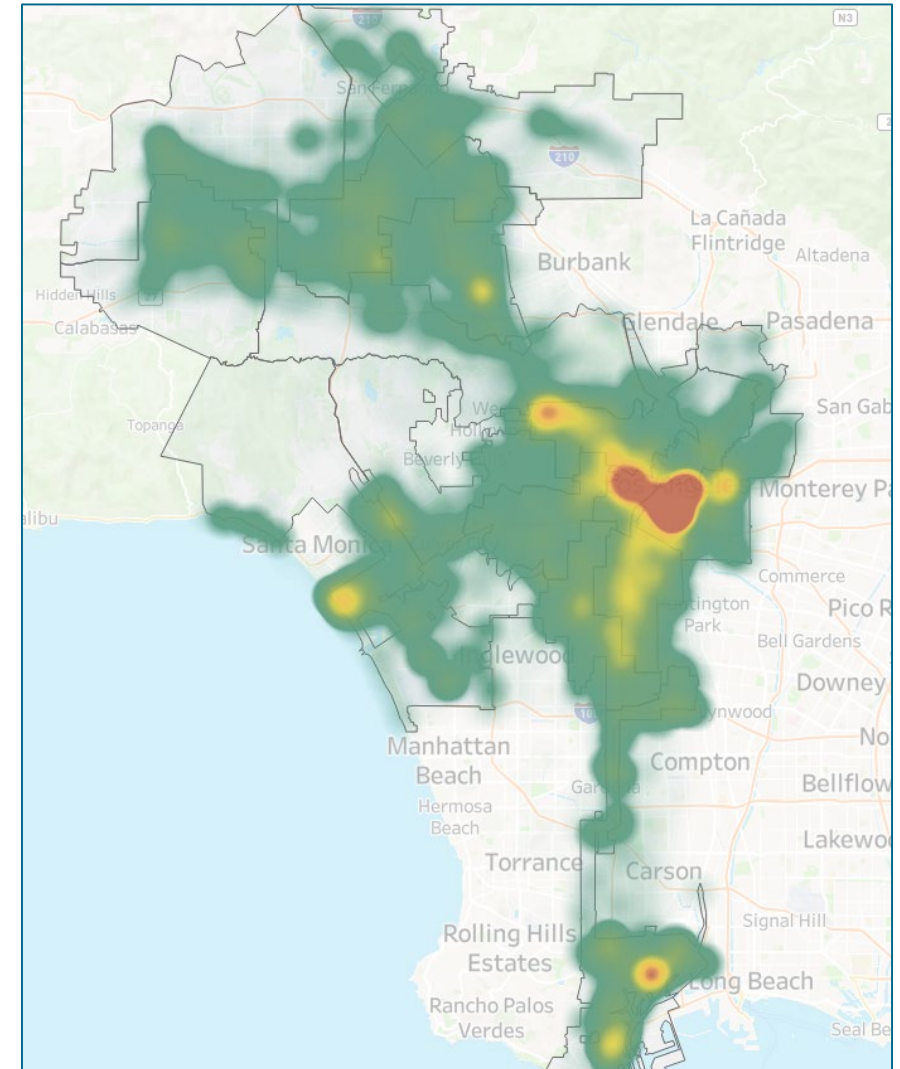

Heatmap of all Current Living Situations in FY25 Q4 in City of LA

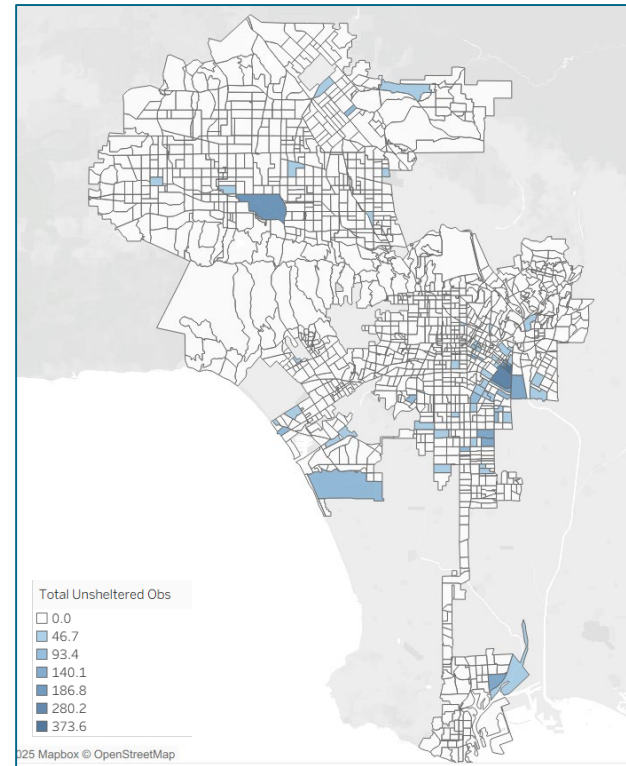
# Point-in-Time (PIT) Homeless Count Data

## About PIT Data

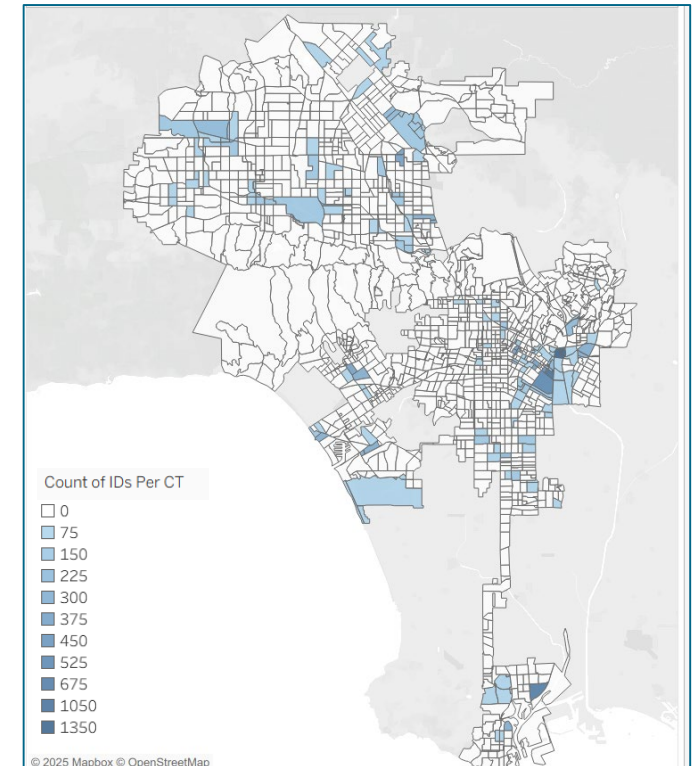
- Collected via volunteer visual count during the nights of the Homeless Count
- Counts by Smaller Geographies, including Council Districts, can only be off raw counts of people and dwellings (cars, vans, tents, etc.), as the multipliers are not designed to be accurate at this level.

## 2025 PIT Data

- 26,972 Unsheltered (+/- 918) estimated for full City
  - 6,321 Unsheltered PEH observed
  - 11,010 Dwellings observed
