Report Back on Feasibility Motions for the A Bridge Home Program

SUMMARY

This report summarizes the status of the feasibility motions for potential A Bridge Home program sites. It also recommends closing a number of Council Files if the site(s) named in the motion have been deemed infeasible.

RECOMMENDATIONS

That the Homeless Strategy Committee review the following recommendations and forward to the City Council for consideration:

- 1. INSTRUCT the City Clerk to close the following Council Files due to site infeasibility for bridge housing: 12-1549-S12, 15-1138-S29, 18-0351, 18-0446, 18-0841, 18-1022, 18-1218, and 18-1221. The sites requested for review in the associated files have been determined to be infeasible for the reasons outlined in Table 2 below; and
- 2. INSTRUCT the City Administrative Officer to report back on the site motions currently in the feasibility review process.

BACKGROUND

According to the 2018 Greater Los Angeles Point in Time Homeless Count released by the Los Angeles Homeless Services Authority (LAHSA), there are a total of 31,516 homeless individuals residing within the City, of which 23,114 are unsheltered. In April 2018, the Mayor and City Council declared a shelter crisis in the City of Los Angeles and adopted alternative health and safety standards to streamline shelter development at sites leased or owned by the City, while ensuring the safety of residents. To respond to this crisis and the immediate need for shelter, the Mayor and Council have allocated \$81,079,797 to establish new crisis and bridge housing facilities with a goal of adding 50 to 100 new beds per Council District. This amount is comprised of the \$20 million Crisis and Bridge Housing Fund established in the 2018-19 Adopted Budget, \$51,079,797 committed and reserved for bridge housing in the City's Homeless Emergency Aid Program (HEAP) allocation, and \$10 million included in the Unappropriated Balance (Homeless Services Program) in the 2018-19 Adopted Budget.

As of April 19, 2019, the Council had approved 25 motions to determine feasibility of potential A Bridge Home facilities. The City Administrative Officer (CAO), with the assistance of the Bureau of Engineering (BOE), Chief Legislative Analyst (CLA), and LAHSA were instructed to evaluate each site to determine if they were suitable for bridge housing.

ACTIVE, COMPLETED OR PENDING SITES

The sites listed in Table 1 below are either active, pending or complete. Sites that have been determined to be feasible and are under construction or awaiting the start of construction are listed as active. Those under feasibility review are pending, and sites where construction has been completed that are either operating as A Bridge Home sites or will begin operations in the coming weeks are completed. Four (4) sites are completed. Four (4) sites are under construction, seven (7) sites have received funding approval and are moving into the construction phase, and one (1) site is awaiting Council approval of funding. Ten (10) sites are still undergoing a feasibility review. Table 1 lists these based on the site type: temporary facilities, permanent structures, and completed facilities.
