Effective January 7, 2018, an employee in the classification of Senior Animal HHH. Keeper, Code 4305, or Principal Animal Keeper, Code 4312, who has met the qualifications and is designated by Management to be a member of the Los Angeles Zoo Emergency Firearms Team (EFT), shall receive additional compensation in the amount of \$75 per biweekly pay period as an EFT member or \$100 per biweekly pay period when designated as the EFT captain. This compensation is non-pensionable.

All other provisions of the 2023-2028 MOU 12 remain unchanged.
