**AMENDMENT NO. 1
PARK RANGER REPRESENTATION UNIT (MOU NO. 65)**

The Los Angeles Airport Peace Officers Association and the City of Los Angeles have reached agreement on the addition of Juneteenth as a paid City Holiday. The MOU is hereby amended as follows.

The following subsection of Article 5.2 – Vacations are **amended**, as follows:

- H. In addition to vacation accruals described above, each bargaining unit member who has completed at least one full year of City service shall be credited with an additional 112 hours of vacation on January 1st of each calendar year. This 112 hours is provided as a replacement for holiday time off that was relinquished previously.
- I. The following table illustrates vacation accrual benefits. The table section, “Additional Vacation Hours In Lieu of Holiday Time Off” will be updated from 112.

All other provisions of Article 5.2 remain unchanged.

The following subsection of Article 5.3 – Holiday Premium Pay is **amended**, as follows:

- A. Employees who work on the following holidays shall receive time-and-one-half premium pay in lieu of their regular salary.
 - 1. New Year's Day (January 1st)
 - 2. Easter Sunday
 - 3. Memorial Day (last Monday in May)
 - 4. Juneteenth
 - 5. Independence Day (July 4th)
 - 6. Labor Day (first Monday in September)
 - 7. Veteran's Day (November 11th)
 - 8. Thanksgiving Day (fourth Thursday in November)
 - 9. Christmas Eve (December 24th)
 - 10. Christmas Day (December 25th)
 - 11. New Year's Eve (December 31st)

All other provisions of Article 5.3 remain unchanged.

**MOU AMENDMENT NO. 1
PARK RANGER REPRESENTATION UNIT (MOU NO. 65)**

Except for the amendment specified herein, Articles and/or provisions of the 2021-2022 MOU No. 65 shall remain in full force and effect during the term of the MOU.


