Summary of Round:

- LA County to publish new application module updates in May 2025:
 - Infrastructure applications will be split into two types: Concept/Design and Construction/O&M
- No new project applications are being proposed this round:
 - WASC budgets are still limited in the next two years
 - o The City (DWP and DPW) are likely to submit PMRs to cover existing project shortfalls in October
 - There are many third party projects applying for the first time or for next-step funding
 - The City is already exceeding available project delivery resources (BOE, BCA)
 - Uncertain economic conditions

Item 2: Ballona Creek TMDL Project O&M (LASAN, CD 11)

Description:

- Status- Currently in construction at 76%. Construction phase: 11/2022- 2/2026
- Budget- Total Construction Cost: \$81,273,301 (\$22M Regional)
- Benefits- Mitigates Dry Weather for 69,361-acre drainage area:
 - Meets BC Bacteria TMDL and TSO (expired)
 - Two facilities supports public health in the Ballona Estuary and Wetlands
 - Provides ~5,060 AF/yr of water supply for recycling.

Location:

- Two years of Optimization and then one year of Standard O&M
- A five year O&M request will be submitted to Regional SCWP in a future Round after cost baseline established
- Leveraging funds in FY 26/27 (25% of first year) funded by projected capital funds surplus, partner cost-sharing MOA, and Municipal O&M contracts


