SUBJECT: FY 2024-25 PROPOSITION K MAINTENANCE FUNDING APPLICATION

#### RECOMMENDATION

That the L.A for Kids Steering Committee (Steering Committee) authorize the Bureau of Engineering (BOE) to release the application for FY2024-25 Proposition K Maintenance Funds (July 1, 2024, to June 30, 2025).

#### **DISCUSSION**

BOE has prepared the Instructions for Application for FY 2024- 25 Proposition K Maintenance Funds and the associated Application Form (Attachment No. 1).

Subject to action by the Steering Committee and the approval of this report, the application is scheduled to be released on November 1, 2024, and due back before 3:00 p.m. on February 6, 2025.

Approximately \$4,484,576 will be available for maintenance awards for reimbursement of eligible maintenance expenses incurred from July 1, 2024, through June 30, 2025.

Eligibility for maintenance funding is restricted to projects with active service payback during the respective fiscal years, and that are compliant with their Service and Maintenance obligations, which for non-city entities are specified in their respective Proposition K Grant Agreements.

It is noted that last year BOE received a grand total of 23 eligible applications. BOE expects to receive a similar number of applications this year.

Subject: Instructions for Applying for Proposition K Maintenance Funds:

July 1, 2024, to June 30, 2025

#### A. General Information

This memo describes the application process for the 2024-25 Proposition K Maintenance Funding for reimbursement of eligible maintenance expenses.

Eligibility for 2024-25 Proposition K Maintenance Funding is restricted to projects completed on or before December 31, 2024, as reflected in the project's *Certificate of Occupancy* or *Notice of Completion issued by Building and Safety* or a *Certificate of Completion* issued by BOE. Applicants must also be compliant with their Service and Maintenance obligations, which for non-City entities are specified in their respective Grant Agreements. Eligible maintenance expenses must be incurred from July 1, 2024 to June 30, 2025.

Agencies are responsible for adequately maintaining Proposition K funded improvements regardless of whether maintenance funding is awarded. Due to limited funding availability, it is unlikely that Proposition K will fully offset annual maintenance expenses. Agencies that have been awarded maintenance funds in prior years are still required to submit a new application for the 2024-25 Proposition K Maintenance Funding process. Prior to payment, all maintenance award recipients will be required to submit documentation substantiating the incurrence of eligible maintenance expenses during the award period. Additionally, non-City agencies will need to execute or amend a maintenance funding contractual agreement administered by the Department of Public Works: Bureau of Engineering.

The <u>only</u> method for submitting the maintenance application is by email. Agencies that do not receive an electronic application via email may obtain one from the contact listed under Section D of this memorandum. To be considered responsive for supplemental maintenance funding, a separate maintenance application completed fully in the format provided in the attached form is required for each facility or project that received Proposition K funds for capital improvements. The application form may be modified to add additional rows, as needed. Handwritten applications will not be accepted.

## **B.** Eligible Maintenance Expenses

Maintenance funds can only reimburse expenses associated with maintaining the specific facility improvements funded by Proposition K project funds. Depending on the nature of the Proposition K facility improvements, eligible maintenance expenses could include custodial and landscaping services and building and equipment repairs.

For this maintenance funding application process, **only** expenses pertaining to the items listed below and specified time periods are eligible:

## 2024-25 Maintenance Funding (July 1, 2024, to June 30, 2025):

- 1. Active service payback period from July 1, 2024, to June 30, 2025;
- 2. Expenses that are determined to be for maintaining the specific facility improvements funded by Proposition K;
- 3. Graffiti removal;
- 4. Brush clearance;
- 5. Regulation 4 compliance testing, servicing, and repairs (for fire-life safety systems):
- 6. Pension, health, vacation, sick leave, or other benefits for maintenance staff;
- 7. Eligible expenses incurred from July 1, 2024, through June 30, 2025; and
- 8. In completing the application, the agency will have to include estimates of expenses incurred through June 30, 2025.

### C. Ineligible Expenses

Ineligible expenses for maintenance funding under this memorandum include, but are not limited to, the following:

- 1. Contributions and donations;
- 2. Travel and entertainment: Costs of travel, amusements, social activities and incidental costs, such as meals, beverages, lodging and gratuities relating to entertainment, or any political or lobbying activity;
- 3. Fines and Penalties: Costs resulting from violations of, or failure to comply with Federal, State, and local laws and regulations;
- 4. Interest and Other Financial Costs: Interest or borrowings (however represented), bond discounts, refinancing of property or of facilities, cost of financing and refinancing operations, and legal and professional fees paid in connection therewith, other than those specifically allowed in advance;
- 5. Membership Expenses: Membership expenses are specifically disallowed;
- 6. Meeting Attendance: Grantee's staff costs of attending meetings with City, and/or its consultants, and Grantee's staff and/or subcontractors;
- 7. Losses: Due to theft, vandalism and/or misconduct of Grantee's staff;
- 8. Losses due to delay: Lack of scheduling, coordinating, and monitoring;
- 9. Non-competitive Subcontracts: Payments under a subcontract not obtained under competitive bidding procedure unless specifically waived by the City;

- 10. Costs incurred prior to the date of execution of this Agreement unless specifically allowed hereunder;
- 11. Operating license fees;
- 12. Grantee's program staffing costs;
- 13. Non-maintenance equipment costs;
- 14. Cost of furnishings;
- 15. Utilities:
- 16. Personal hygiene products such as toilet paper, tissue, bars of soap; and
- 17. Expenses that are determined to be unrelated to the original scope of the Proposition K project.

# D. Application Due Date & Submission Instructions

Applications must be <u>received electronically</u> on or before 3:00 p.m. Pacific Time on Thursday, February 6, 2025. Submit applications only by email to <u>engpropkrfp@lacity.org</u>. If you have any questions, please contact Eden Gascon at (213) 485-4819. It is the responsibility of the applicant to ensure that the application is received by the deadline stated above.

### E. Notification of Funding Award

City staff will review the applications and will recommend projects and funding amounts to the L.A. for Kids Steering Committee. The recommended maintenance awards will then be submitted to the City Council for approval. Agencies approved for maintenance funding will be notified of both the funding amount recommended by the L.A. for Kids Steering Committee and the final amount of the maintenance award approved by the City Council.
