MEASURE A - HISTORICAL BACKGROUND

In November 2016, 75% of Los Angeles County (County) voters approved the Los Angeles County Safe, Clean Neighborhood Parks and Beaches Measure (Measure A). Funding through the Measure A grant program will be generated in perpetuity through the collection of a parcel tax, with an estimated total annual funding of \$96.8 million across the County. Measure A provides the City of Los Angeles (City) formula-based annual allocations for capital improvement projects under the Community-based Park Investment Program (Category 1) and Neighborhood Parks, Healthy Communities, & Urban Greening Program (Category 2) as well as additional annual allocations under the Maintenance and Servicing Program to offset Proposition A and Measure A funded capital projects. Furthermore, Measure A provides competitive grants for capital improvement projects under Natural Lands, Local Beaches, Water Conservation and Protection (Category 3) and Regional Recreation Facilities, Multi-use Trails and Accessibility (Category 4); as well as program grants under Recreational Access (Category 3 and 4) and Youth and Veteran Job Training and Placement (Category 5). When funding is available, Los Angeles County Regional Park and Open Space District (RPOSD) serving as the Measure A Grantor, may announce additional grant opportunities such as innovation grants under the Implementation, Operations and Oversight Category. In October 2018, City Council designated the L.A. For Kids Steering Committee (LAFKSC) as the administering entity for Measure A with RAP serving as the Grant Administrator (Council File 18-0611).

MEASURE A CATEGORY 1 AND 2 ANNUAL ALLOCATION PROGRAM

Measure A's Category 1 and 2 Annual Allocation Program is a formula-based grant program in which allocation funding is distributed to each of the City of Los Angeles' 43 Study Areas. Measure A's need-based approach establishes a per capita and structural improvement formula to determine the percentage of parcel tax revenues annually allocated to each study area. Whereas all Study Areas receive Category 1 annual allocations, only Study Areas with need categorized as "High" and "Very High" receive Category 2 annual allocations. Each Study Area has its respective allocation balance which increases as new allocations are received every September and decreases as grant awards/receipts are deducted. Funding allocated to each Study Area is intended to address the Study Area's park needs and to fund park projects within its defined geographic boundaries. In order for RAP to access funding allocated to a specific

Study Area, RAP would need to apply for and receive a grant award for a park project located in the respective Study Area. There is no sunset or expiration date for Category 1 and 2 funding. In accordance with Measure A guidelines, park agencies such as RAP may expend and/or accrue all or a portion of their total annual allocations per Study Area for park planning and design, feasibility studies, environmental planning and capital improvement projects. RAP continues to work with the Council Districts and Mayor’s Office in order to develop future grant applications to improve existing parks as well as develop new parks.

GRANT HIGHLIGHTS

Recent RPOSD Annual Allocation (Category 1 and 2)	On September 15, 2025, RPOSD announced the latest Fiscal Year 2025-26 annual allocations for all Study Areas as well as the Maintenance and Servicing Program. See Attachment 1 and 2. Next Annual Allocations will be announced on September 15, 2026.
Active Measure A Grants	RAP is presently implementing 24 awarded grants totaling \$30,577,339. See Attachment 3. These include projects awarded under Measure A’s various grant opportunities including Annual Allocations, Competitive, RESTORE, and Technical Assistance Program. Recently awarded Annual Allocation grants include Sunland Park Dog Park (CD 7) (\$1.35 million), South LA Wetlands (CD 9) (\$4.2 million) and Lummis House Planning Grant (CD 1) (\$250,000).
Recently Completed Projects	In addition to 15 completed play area and fitness area replacements, a new playground at Chatsworth Oaks Park (\$770,000), Griffith Park Riverside Dr. Multi-use Trails Project (\$920,000), and Hope and Peace Playground Replacement (\$440,000) are now open to the public. RAP in the process of administratively closing out these grants.
2024 Competitive Acquisition-Only Grant	In April 2025, RPOSD awarded RAP \$2 million grant to acquire approximately 6 acres of land that runs along the Route 170 Freeway in Los Angeles, for the expansion of Strathern Park West.
2025 Technical Assistance Program (TAP) Allocation	In June 2025, RPOSD awarded RAP \$700,000 in support of efforts to create new parkland or expand existing parkland.
2025 Recovery and Emergency Support for Trails, Open Space,	In Summer 2025, through an initiative responding to the January 2025 fires, RPOSD awarded RAP \$1 million in RESTORE grants to restore park land impacted by the fires. RAP is presently completing projects

and Recreation (RESTORE) Grants	at George Wolfberg Park (CD 11) and Wattles Garden Park (CD 4). In addition, RPOSD also awarded RAP \$350,000 in partnership grant funding to pay for the services of the Los Angeles Conservation Corps to restore portions of Temescal Canyon Park.

2025 Parks Portal Update	RAP updated park data and conditions assessments in RPOSD's LA Parks Portal. Agencies that own or manage parks in Los Angeles County are required to update their park inventory data in the Portal on a biannual basis as a condition of eligibility to receive Measure A funds. The Portal displays the most recently published inventory data and condition assessments for parks across the county.
