**MOU AMENDMENT NO. 1  
THE INSPECTORS UNIT  
(MOU #05)**

The Municipal Construction Inspectors Association and the City of Los Angeles have reached agreement on the deletion of the Cesar E. Chavez Birthday paid holiday and the addition of Farm Workers Day paid holiday. The MOU is hereby amended as follows.

The following subsection of Article 6.5 –Holidays is **amended** as follows:

**ARTICLE 6.5        HOLIDAYS**

A.     The following days shall be treated as holidays:

1.     New Year's Day (January 1)
2.     Martin Luther King Jr's Birthday (the third Monday in January)
3.     President's Day (the third Monday in February)
4.     **Farm Workers Day** (the **last** Monday in March)
5.     Memorial Day (the last Monday in May)
6.     Juneteenth (June 19)
7.     Independence Day (July 4)
8.     Labor Day (the first Monday in September)
9.     Indigenous Peoples' Day (the second Monday in October)
10.    Veteran's Day (November 11)
11.    Thanksgiving Day (the fourth Thursday in November)
12.    The Friday after Thanksgiving Day
13.    Christmas Day (December 25)
14.    Any day or portion thereof declared to be a holiday by proclamation of the Mayor with the concurrence of the City Council by resolution.
15.    Two (2) unspecified holidays (floating holiday)

All other provisions of MOU 05 remain unchanged.

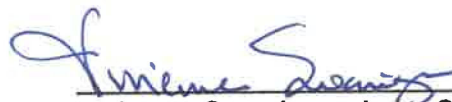
