to the Fiscal Year 2020-21 Project Expenditure Plan

RECOMMENDATION

That the Proposition HHH Citizens Oversight Committee (COC) review and forward this information to the Proposition HHH Administrative Oversight Committee (AOC) to Note and File.

SUMMARY

On December 10, 2024, the Mayor and City Council approved the Hutt-McOsker motion (C.F. 17-0900-S26) that adds three (3) Project Homekey1 (PHK1) sites to the Proposition HHH (Prop HHH) Fiscal Year (FY) 2020-21 Project Expenditure Plan (PEP) for a total funding commitment of \$3,605,586.

BACKGROUND

The City, led by the Office of the City Administrative Officer (CAO), with the assistance of the Housing Authority of the City of Los Angeles (HACLA) acquired the three (3) PHK1 sites in December 2020 as interim housing sites. The PHK1 sites had been approved for early conversion to permanent affordable and supportive housing, but experienced funding gaps. The CAO, with assistance of the Los Angeles Housing Department (LAHD), determined the Prop HHH uncommitted balance as of October 2024 to be \$9.1 million. This action commits \$3,605,586 of this uncommitted balance. This action will allow the PHK1 sites to proceed with the conversion from interim housing and develop up to 95 permanent housing units. The funding commitments include:

- Up to \$1,343,914 for the Best Inn/Mollie Maison located at 4701 Adams Blvd, Los Angeles, CA, 90016 in Council District 10 with owner/operator, The People Concern;
- 2. Up to \$1,525,457 for Ramada Inn/PV Marina Del Rey located at 3130 Washington, Blvd, Venice, CA 90291 in Council District 11 with owner/operator PATH Ventures; and,

3. Up to \$736,215 for Travelodge Normandie/Normandie located at 18606 Normandie Avenue, Los Angeles, CA 90248 in Council District 15 with owner/operator PATH Ventures.

This action also provides authority to update legal documents, including revisions to the ownership structure for the three PHK1 sites and one additional site in Council District 4. Once the sites start the conversion process, the projects are transferred to the LAHD permanent housing portfolio.

HOUSING AND HOMELESSNESS COMMITTEE REPORT relative to approving the Prop HHH funding commitment for three projects and adding them to the Fiscal Year 2020-21 Proposition HHH Project Expenditure Plan (PEP).

Recommendations for Council action, as initiated by Motion (Hutt - McOsker), SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. APPROVE the Prop HHH funding commitment for the following projects and the addition of the projects to the Fiscal Year 2020-21 Proposition HHH PEP:
 - a. Up to \$1,343,914 for the Best Inn/Mollie Maison, 4701 Adams Boulevard, Los Angeles, CA, 90016, Council District 10; owner/operator, The People Concern.
 - b. Up to \$1,525,457 for Ramada Inn/PV Marina Del Rey, 3130 Washington, Boulevard, Venice, CA 90291, Council District 11, owner/operator PATH Ventures.
 - c. Up to \$736,215 for Travelodge Normandie/Normandie, 18606 Normandie Avenue, Los Angeles, CA 90248, Council District 15, owner/operator PATH Ventures.
- AUTHORIZE the General Manager, Los Angeles Housing Department (LAHD), or designee, to negotiate and execute loan documents, covenant/regulatory agreements, and any other documents necessary to implement the Fiscal Year 2020-21 Proposition HHH PEP with each of the borrowers/owner/operator for these projects, subject to the approval of the City Attorney as to form.
- 3. AUTHORIZE the General Manager, LAHD, or designee to prepare Controller instructions or make necessary technical adjustments, subject to the approval of the City Administrative Officer, to implement the intent of this motion, and request the Controller to implement those instructions.
- 4. REQUEST the City Attorney, with the assistance of the LAHD, to update the City legal documents with the owner/operators of these sites to include the changes in the ownership structure for the conversion to permanent housing as follows:
 - a. Ramada Inn/PV Marina del Rey: from PATH Ventures to PV MDR LLC.
 - b. Travelodge Normandie/Normandie: from PATH Ventures to PV Normandie LLC.
 - c. Homekey1 site, Howard Johnson/The Sieroty, at 7843 Lankershim Boulevard. North Hollywood, CA 91605, in Council District Four, which does not have a funding gap, from LA Family Housing to LAFHBuilds.

<u>Fiscal Impact Statement</u>: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.


